# For Information post meeting Sidemoor and Moortown Picnic Areas.

Although not on the agenda as the information had arrived too late, the chairman spoke about the two picnic areas in the Parish, adjacent to the A361. He stated that he had been expecting an update from Devon County Council once they had decided a plan for the two picnic areas. When the tenancy for the Log Cabin Diner was renewed this was thought to be encouraging as it was thought to be for a further year. However, having been made aware of the "For Sale" signs we now know that both the sites are for sale and the tenancy at the Moortown site is only until a sale is completed. The decision to sell was made by the County Council Land and Property Committee on 18<sup>th</sup> September 2025. Documents regarding the sale can be found on the Rightmove website. Questions remain regarding planning requirements for any purchaser but the council will watch the situation with interest.
