19/69 Finance

- a) Financial Report by RFO. The accounts and bank reconciliation to date were REVIEWED. The Clerk reported that the VAT refund of £381.42 had been received from HMRC. The Council had not yet received an invoice from Fremington Parish Council for the new councillor training.
- b) Accounts to settle:

• Wendy Sweet – pay & holiday pay (£190.74) & expenses (£42.51) £233.25 It was RESOLVED to settle the above account, Cllr Moore proposed, Cllr Filmer-Bennett seconded, all agreed

19/70 Planning

- a) Applications notified since last meeting Ref .70190 Change of Use of land to allow formation of a Manège for private use at West Hill, Knowstone Cllr Howe reported that he had made a site visit and saw no reason for the applicant not to create a training area for their horses. It was RESOLVED to support the application, Cllr Howe proposed, Cllr Pomfret seconded, all agreed
- b) Applications determined since last meeting None
- c) Oaklands Chicken Farm Cllr Howe reported that he had attended a meeting in East Anstey to discuss making representations to the Planning inspectorate. He had submitted a letter on behalf of KPC the main point of which was the probable loss of the proposed affordable housing and reiterating that had the applicant gone through the planning process in the correct way the application would undoubtedly have been refused. East Anstey PC's response focused on the creation of an industrial place where once there had been a meadow.
- d) East Hill Farm update Cllr Ley said that due to holidays he had been unable to speak to the person he needed to about the breach of planning conditions regarding access to the site. The clerk flagged up that an application had been submitted by Kingston Contractors to vary the conditions of the planning permission including condition 8 re. site access. It was AGREED to delegate powers to Cllr Moore and Cllr Howe to put together and submit a response.
- e) Discuss and agree KPC's response to NDC's proposal to remove two telephone boxes in the Parish. It was pointed out that the telephone in Knowstone had been disconnected some time ago. No feedback had been received from the community. It was RESOLVED to submit a 'no comment' response, Cllr Moore proposed, Cllr Filmer-Bennett seconded, all agreed.
- f) Cllr Howe reported that he had met with Cllr Maidment to discuss the welcome pack and they are suggesting that it includes an item on planning encouraging residents to attend the relevant parish council meeting if they want to do something on their property that involves a planning application.
- g) It was pointed out that when responding to a planning application that the council has considered

it needs to give reasons for its objection or support, based on planning criteria.

19/71 East Hill Working Group The Group has not met yet due to holidays. The Chairman reported that Timothy Browse will join the Working Group

19/72 Third Party Reports

a) District Councillor – Re. West Hill planning application Cllr Ley said there is an issue with

the barn conversion as the proposal extends its footprint by 17% which policy does not allow. This is quite a major stumbling block and he is not sure what the outcome will be. The Planning Minutes 19/20 Page 19

Department may not want to set a precedent by allowing it. He encouraged the council to respond to NDC's Corporate Plan. He pointed out that the council is hamstrung by what comes down from central government.

b) County Councillor - not present

19/73 Members Reports

a) Highways - Cllr Filmer-Bennett reported the following:

(i) The council had recently voted to improve the approach to Roachill from the east end and this is almost complete with the final bit of brushing down still to do. Before and after photos were shown to the meeting.

(ii) C/Cllr Jeremy Yabsley and traffic officer had recently visited the parish. Signage for East Knowstone had been blocked by the traffic officer who was not convinced of the agreement to change the signage. C/Cllr Jeremy Yabsley will now chase Tom Vaughan at DCC and urgently request that the work is done.

(iii) The request for speed indicators has not yet come in front of the relevant committee. A case needs to be made for their installation and to this end a speed testing exercise is being carried out. Two days have been done so far with one more due to take place. A report with the findings will be sent out in due course.

(iv) Consultation with Roachill – Cllr Filmer-Bennett had written to all residents and a copy of the letter was circulated at the meeting. 54% had responded to the two questions - (1) Residents unanimously did not want to go down route of sending a solicitor's letter but requested that KPC writes a letter to the haulage companies and copies in the Environment agency. Cllr Filmer-Bennett will draft a letter via the clerk. (2) 20 is plenty campaign – all residents were in favour of participating in the voluntary scheme which involves displaying signs that say '20 is plenty'. Cllr Filmer-Bennet would like to ask KPC to go down that route.

(v) Cllr Filmer-Bennett gave advance notice that he will be asking KPC to consider and agree the road closure for next year's fair. In discussions with Highways he will be able to use a 'fair open today' sign to avoid confusion for people wishing to attend the fair.

- b) Footpaths & Beaples Stone Cllr J Pomfret reported that he expects to meet with Ros Davis next week in the parish. He had asked her about the Two Moors Way alternative route as he had seen workmen working on the former crossing and has been told that the alternative route is staying. He had not heard back re. tick warning signs which had been raised at the last meeting. It was queried whether there should be a warning about deer keds but although they can bite they are not dangerous in the same way as ticks. No progress yet on obtaining quotes for renewing the wording at Beaples Stone The damaged Two Moors Way sgnpost by the cattle grid has been reported.
- c) **Police** Cllr Moore not much to report. The main thrust was around domestic abuse and warning people not to leave doors and windows open when it's hot and they go out..
- d) Parish Pound Cllr Howe nothing new to report
- e) **Parish Hall** Cllr Howe reported that the next meeting is on 5th September when the committee will be making decisions regarding next year's fair. The organisation of film nights has been taken over by Chris and Phil Dey and the first two dates are Thursday 7th November and Thursday 5th December. There will be a Quiz Night on Saturday 19th October
- f) PCC Cllr Howe the Harvest festive will take place on Saturday 14th September at 7.00 p.m., followed at approximately 7.30 p.m.by the supper and auction of produce. The auctioneer will be Geoff Clapp. The last piece of work to be done on rood loft steps project is the replacement of the choir stalls which will be quite an expensive job. This is because the church is a grade 2 listed building and it has to use as much of the original wood as possible which has to be knitted

together. The PCC is going ahead with applying for a faculty to install under pew heating and will also be applying to the Batsworthy fund for financial assistance.
